Our decline can be traced back through our failure to lay that first brick with the masonic mortar that it was intended to be laid with.

It was my honor to host the first Grand Masters Day of Master Masons at the Grand Lodge where four (4) Brothers were raised to the Sublime Degree of Master Mason, with the hopes that this will become an annual event for the craft to take advantage of. A product of this event sparked the first annual Open House of the Grand Lodge which resulted with over 100 brothers and family members attending.

It was my honor to attend the Imperial Shrine Session with the India Shrine Brothers where my wife and I were treated with the utmost hospitality and respect, I thank the Nobles and their Wives for a great week of friendship and education we received during the time spent with all of you.

I had the great honor and privilege to appoint one trustee to the Charles Page Foundation in Sand Springs, R.:W.: James Roderick. This to me is a position that requires commitment and dedication, along with a strong work ethic.

GRAND MASTER’S DECISIONS

During the 2021-2022 year I have issued the following Grand Master’s Decisions.

Decision #1

Waiving the work lecture in then Entered Apprentice and Fellow Craft Degree by Substituting the Perpetual Path Program Videos.

Dear Brethren,

This decision is required to be read at the first stated meeting of your lodge after receipt.

The perpetual Path Program is continuing to be a very successful program.

The educational videos being used for proficiency in the Entered Apprentice and Fellow Craft degree have proven to be an outstanding means of teaching these new brethren knowledge about each degree and Masonry in general. These videos are restricted for use during Perpetual Path conferrals only.

To continue to strengthen Oklahoma Masonry, I am issuing the following decision which will permit those who are Entered Apprentices or Fellow Crafts to complete their degree(s) through the Perpetual Path Program provided that they comply with all the requirements of that program.

This decision is in effect during my term of office as Grand Master which commenced on November 14, 2021.

Therefore, it is my decision:

Pursuant to section 202B.12. I have the authority to waive under Section U 505 the requirement of

passing an examination on the work lecture in open lodge.

I hereby waive the requirement for turning in the work lecture (categorical lecture) in open lodge and substitute the requirement of viewing the Entered Apprentice and Fellowcraft educational videos by all Perpetual Path candidates.

Decision #2

TO: MEMBERS OF POTEAU LODGE # 46

This letter is to inform you that I had a question brought before me by the Grand Secretary as to the election of the Worshipful Master in your lodge. The issue in question is that we found no record where Brother Christopher Scarborough has been elected to serve as a Warden in a Lodge. In Section U 204 Of the Constitution and code of the Grand Lodge of Oklahoma, to be eligible for the office of Worshipful Master, he must have been previously elected and served as a Warden of a regular Oklahoma lodge.

Therefore, it is my decision that Brother Christopher Scarbrough be removed from the office of Worshipful Master to comply with section U 204.

It is also my decision that to fill the vacancy created by this action, Brother Charles E. Whitehead will succeed to this vacancy in accordance to Section U 221, which states in case of the death, removal from the jurisdiction or any other cause, the Master becomes incapable of performing the duties of his office, notwithstanding the provisions of U 418 D, the Senior Warden succeeds to all powers, duties, and responsibilities of the Master.

I hereby direct the Secretary of Poteau Lodge #46 to ensure that every member of Poteau Lodge is informed of these decisions.

To: Members of Sapulpa #170

This correspondence is to inform you that I had a question brought before me by the Grand Secretary as to the initiation of one Brett Lee Bean #223215. The issue in question is that brother Brett Lee Bean #246694 has already been initiated in Akdar Lodge #555 on the 18th day of December 2009. By common sense he cannot be initiated a second time in the same jurisdiction.

Therefore, it is my decision that Brother Bean #223215 be stricken from the records of Sapulpa Lodge #170 to comply with the Constitution and Code of the Grand Lodge of Oklahoma Landmark 16. No lodge can interfere in the business of another lodge nor give degrees to brethren who are members of other lodges.

I hereby direct the Secretary of Sapulpa lodge #170 to ensure that every member of said lodge is informed of this decision. Also, to inform Brother Bean that he must pursue his Masonic journey through Akdar Lodge #555 where he is currently a Enter Apprentice member, according to Section U415 of the Constitution and Code. If a period of 1 year or more shall have elapsed from the time of election, initiation, or passing, the application for advancement shall be in writing on a form furnished by the Grand Lodge and signed by applicants own hand using his full name and shall be subject to the same procedure as a petition for the degrees.

An Entered Apprentice or Fellow Craft must pass the examination in open lodge as to his proficiency before the new ballot is spread. After the brother is declared proficient, the lodge may receive and read an Application for Advancement. An investigating committee will be appointed, and the Application will lay over at least until the next stated meeting.
