## Report of the Grand Treasurer

To the Most Worshipful Grand Lodge of Ancient Free and Accepted Masons of the State of Oklahoma

#### My Brethren:

As I prepare to submit my 10th report as your Grand Treasurer, I want to thank you my Brethren for your support. On behalf of all your Grand Lodge Trustees, we pray that all is well with you and your Families. The past year has been very challenging for everyone. Our Lodges are again starting to meet, have fun raisers and do degrees. None of us could have predicted the dramatic impact the pandemic Corona Virus would have on every aspect of our lives and Lodges.

It is and has been an Honor to serve Masonry in the State of Oklahoma as your Grand Treasurer. I am very proud of our leadership, and I am proud that you have allowed me to be part of that group of Masons. I feel fortunate in having the opportunity to have a small part in building the financial structure of our Grand Lodge. At the same time, I realize that much remains to be done to ensure the financial security and future of our fraternity.

Part of the duties of the Grand Treasurer is to receive all securities and funds for investment belonging to the Grand Lodge, make all investment of Grand Lodge with the approval of the Grand Lodge Trustees. The Grand Lodge Trustees have the fiduciary responsibility to oversee your invested capital. The past two years have not been the best years for investments. These funds are: 1) General Funds, 2) Perpetual Membership Funds, 3) Pension Plan Trust Funds, 4) Deferred Compensation Funds, 5) Building Funds, 6) Chips Funds. As reported in my 2020 Reports, the Museum & Library Fund has been removed from the oversight responsibility of Grand Lodge Trustees, as Museum & Library L is now a 501C-3, with its own board of Trustees.

As reported in the Yellow Book 2022, by a vote of 4 to 3 of Trustees to replace our Bond investor, Hilltop Securities and Equity investor T.S. Phillips with Edward Jones Investment of Enid, Oklahoma. When the funds were transferred to Edward Jones they were sold and reinvested, and this resulted in Realized Losses of Funds.

On October 13, 2022, Glen Chaney Deputy Grand Master, soon to become Grand Master and I met in Lawton, Okla. with Bryan Brown adviser with Edward Jones to review our investments to see how we needed to move forward with all of our investment's accounts, especially our Perpetual Funds. Bryan informed us that our present investment strategy of investing 70% of our funds in equities and 30% in bonds would not achieve our goals.

Several strategies were reviewed to achieve some growth and with income. With the approval of Trustees to re-balance, it was decided on a 50/50 split. 50% of all funds invested in 70% Equity and 30% in Bonds, the other 50% of funds invested in Corporate Bonds which provide higher yields.

Your Trustees have continued working with Edwards Jones to obtain the highest interest and dividends rates available on safe investments. Thought the first ten months of 2023 Grand Lodge year, your Trustees have met monthly and have continued their Fiduciary responsibilities. The budgeted revenue and expense are amortized over the twelve months of operation and to date are well within the guideline of approved Budget for 2023.

Before the transfer of funds and realized losses, as of August 31, 2022, your General Fund had a total investment of \$1,463,178.50. As of August 31, 2023, total investment is \$1,492,599,81, Perpetual Endowed Membership Fund as of August 31. 2022, was \$5,462,259.00. As of August 31, 2023, total investment \$5,346,297.15. We are not experiencing the high rates of return of past years. However, Perpetual Membership is still good for the Brother and his Lodge. Some brethren are adding to their perpetual funds to increase their return to their Lodge. Some are paying the difference between their perpetual fund's earnings and Lodge dues. Some are paying their Grand Lodge Per Capita. The Lodge will never lose a Perpetual member, the member never pays dues unless he chooses to!

There are about 9,468 deceased perpetual members as of 12/31/2022 still supporting their Lodges. Over the past 6 years the perpetual fund has returned to Oklahoma Lodges \$1,446,827.74.

The Pension Trust had Market value as of August 31,2022 of \$57,564.85. As of August 31, 2023, \$45,536.56. In 2020 your Trustees froze the Pension Plan. No new employees will be added to the plan in the future. Building Investment Funds market value as August 31,2022, \$401,181.57. As of August 31,2023, \$430,795.47. Two dollars of your current members per capita is paid each year into our Building Endowment Fund to help keep our beautiful Grand Lodge Building for future generations.

Child ID Funds were \$17,522.12 as of August 31,2022, as of August 31,2023, \$13,573.63.

This year we have been able to recoup some of our investment losses from 2022, however 2023 has not been friendly to investors. The Financial Statements and Auditor's Report as of October 31,2022 (grand lodge year 2022) completed by Russell & Williams CPA's, P.C., has been received and is on file in Grand Secretary office for review.

Finally, I would be remiss if I did not acknowledge the excellent work of our in-House Staff, especially Lady Karen and the Grand Secretary. Their reports and help enable the Trustees to closely monitor the financial Conditions of your Grand Lodge!

## Report of the Grand Secretary

Most Worshipful Grand Lodge A.F. & A. M. of the State of Oklahoma, Most Worshipful Grand Master and Brethren:

It is my pleasure to submit this report to the Grand Master, the Grand Lodge Trustees, and the members of the Craft of Oklahoma.

I begin this, my first report, as your Grand Secretary by extending my personal thanks to the Masons of Oklahoma for giving me the opportunity to once again serve the craft and especially for making the

neccessay changes in our Masonic law to allow Karen to work at Grand Lodge with me. My thanks also to John Christoper for his generosity in helping with the transition into this position. His assistance has been invaluable to me. Thank you also to M :: W :: Bobby Laws, M :: W :: Max Tatum and <math display="inline">M :: W :: Garry Odom for their wise counsel and guidance during this past year.

We began the year with several challenges: inadequate staffing, a decreasing budget, increasing operational costs, and further modification of our accounting system by bringing the employee payroll functon in house.

Among the projects we took on soon after coming into office was the continuation of the development of written procedures started last year. This is an ongoing project that may take some time to complete. We also completed a top to bottom review of the Perpetual Membership records and we are now confident that the Perpetual Membership records are as accurate as possible and that the annual recapitulation calculations are accurate. We started reorganizing lodge files in the office. These files have been stored in four separate locations based on the document type, and we are now consolidating each lodge's files into a single group of files, organized by lodge number with appropriate sections. Now we have only one location to search for any document related to a specific lodge.

#### Staff

As many of you know Karen Dixon had been volunteering for some time prior to the previous office staff leaving. The Trustees asked her to come on full-time and she agreed to their request. Since coming onboard, Karen has become somewhat of an expert on Grandview, coupled with her previous expertise in office management, operations, experience and her working knowledge of the Fraternity, she has become a huge asset to us all, including the craft.

Very early in the year we put out a call for volunteers to help out at the office. Two men immediately stepped up, W∴ Robert Ellison of Yukon Lodge No. 90 and Brother Buddy Givens of Uriah Lodge No. 227. Brother Givens, a retired CPA, was a huge asset in examining the 22,000 individual records in the Perpetural Membership system. W∴ Ellison has religiously worked a full day a week almost every week since February. Their contributions to the Grand Lodge has simply been invaluable. Gentlemen, please accept my most heartfelt thanks!

Colleen Barker was hired last October to fill the vacant part-time position. However, after several months, she was forced to leave us for personal reasons. By mid-March we hired W.: Jay Wall, of Edmond, to fill the part-time vacancy. Jay is retired from the Oklahoma Highway Safety Office of the Department of Public Safety. As we began preparations for the Annual Communication, it became apparent that we were not going to be able to keep up with the demands of the office. Subsequently, Colleen agreed to return to work on a limited basis to supplement the office staff.

In his Grand Secretary's report last year, John Christopher addressed the salary and employment conditions for Grand Lodge employees. I feel that it is important that I address this issue again, not for my benefit but for the benefit of the Grand Secretaries and Grand Lodge staff coming along behind me.

The Grand Secretary and the Administrative Assistant positions are salaried positions, and therefore, they are not paid for any overtime hours. It is noteworthy that both positions require work on numerous weekends and even a Holiday or two over the course of the year. The office staff handles an estimated average of 40 - 50 inbound telephone calls every day. These calls take from a few minutes to nearly an hour, expecially when the calls involve Grandview user support. At the time of this report, our staff has processed over 100 out-of-jurisdiction matters. Staff has posted more than 3,345 financial transactions in the accounting system, including 700 individual sales transactions for lodge supplies, service pins, ritual ciphers, etc. To accomplish this, the Grand Secretary and Administrative Assistant's average work week is 50 hours. Many weeks, when preparing for various Grand Lodge activities such as Secretary and Leadership workshops and during the last couple of months leading up to the Annual Communication, require several hours more per week. Taking into account uncompensated overtime hours, our staff is paid much less than entry level staff positions in almost any other business. In addition to uncompensated overtime, significant travel is required of the Grand Secretary and Adminstrative Assistant. Because of the ever decreasing budgets, all of the travel expenses for the Grand Secretary and office staff is uncompensated, as is most of the travel expenses for the elected and appointed Grand Lodge Officers.

Skills required for working in your Grand Lodge office have changed dramatically over recent years. Today our staff positions require experience and proficiency in a number of areas such as modern computer applications; word processing, database software,

accounting procedures and software, document publishing, document imaging and many others.

Employment for the Grand Lodge has been structured with the ability to hire only those persons who are retired or have another source of income and do not need benefits such as retirement or health care. The only benefit provided by Grand Lodge is an occasional holiday off. This model works well to reduce employee costs, but it strictly limits the potential employee pool. Employees in this category are not usually long-term employees which means the Grand Lodge staff could be in a constant retraining mode. In the not too distant future, potential employees that possess the skills required in the Grand Lodge office. will only be attracted to employment if a competitive wage and benefit package is funded in the annual budget. It is becoming increasingly more difficult to provide the services expected of this office without available staff. We must find a way to fund a minimum of two full-time positions in addition to the Grand Secretary and all must possess the required skills to be effective in their respective positions. We must provide our employees with reasonable vacation time, heatlh benefits, and perhaps some form of retirement benefits.

Even when fully staffed the Grand Lodge office will still need volunteer help during the critical times to prepare for various functions such as Grand Lodge training progams and preparation for the Annual Communication. We must stop the practice of expecting Grand Lodge staff and Grand Officers to volunteer significant time and spend significant funds from their pockets to support the operation of your Grand Lodge office. Failure to implement these steps could have a catastrophic result on your Grand Lodge.

#### <u>Finances</u>

The conversion to QuickBooks as reported last year has improved the effeciency of management of our financial resources. This year we returned payroll services in house, resulting in additional savings.

When I took office, Grand Lodge had nearly \$10,000.00 in accounts receivables from Lodges. Most of the outstanding balances were for dues notices, dues cards, merchandise orders and per capita dating back as far as September of 2021. At the direction of the Trustees, we undertook several initiatives to lower our accounts receivable. The Grand Lodge staff started an aggressive calling campaign along with sending monthly collection statements to aid in collection of the outstanding balances. On many of these the Grand Master had to

personally call the Worshipful Masters or Lodge Secretaries to get the bills paid. We continue to add a 5% per month late fee on past due accounts. Additionally, the Trustees enacted a policy of requiring payment in advance for all orders for supplies and merchandise from Grand Lodge. Further, for the Lodges that we experienced the most difficulty with collections, dues cards must be paid in advance. These steps have helped to reduce our receivables to less than \$2,000.00.

Utilities, postage, and insurance for the Grand Lodge building continue to increase, adding significantly to the operations costs. We have been forced to defer all maintenance except for those issues that absolutely could not be deffered.

Because of the generous donations of their time and personal resourses of the volunteers and Grand Lodge staff, actual costs of Grand Lodge operations have been reduced; therefore, the acutal cost of operating the Grand Lodge building is significantly more than what is reflected in the annual budget.

In the last couple of years, the craft has not supported the Grand Lodge Fundraising efforts that continue to be spearheaded by the Deputy Grand Master, as much as they supported Grand Lodge in past years. The net proceeds from these fundraisers are dedicated exclusively to the Grand Lodge budget for Deputy Grand Master's upcoming year as Grand Master.

Although we experienced a significant increase of per capita over the last few years, the membership of Oklahoma Masonry must accept the fact that with decreasing membership and increasing costs of goods and services for Grand Lodge operations, including staffing, your Grand Lodge office can not continue to operate at current funding levels. We, as a Fraternity, are going to be faced with some very difficult choices. We must consider increasing funding through per capita and reduce services. The Craft may even be required to consider selling the Grand Lodge building and moving the operations to a much smaller and affordable space.

## **Grandview**

It was reported last year that just 15.5% of our membership had registered on Grandview. As of September 26, 2023, we have only 2,745 registered Grandview users out of a membership of 17,140. Many of these men have not logged into the system in over a year. We continue to have a significant number of lodge Secretaries who, for one

reason or another, do not use the Grandview system. I cannot express strongly enough how important it is for our members and our lodges to take full advantage of Grandview! Grand Lodge must depend on the Grandview data to provide many of the services we are required to provide or what you expect us to provide, such as dues notices, dues cards, proxy forms, the "Blue Book" and many others. This year alone our staff had to make calls to far too many lodges to gather information necessary to process dues notices and the Yellow Book. This year we simply were not able to gather enough data in a timely manner to publish the "Blue Book." The ability to effectively communicate between the Grand Lodge and constituent lodges is extremely important to every member of the craft. With the recent rise in postal rates and cost of goods, it costs the Grand Lodge, and by extension the craft, \$175.00 every time we mail a single letter to each of the lodges. The increases in postage costs have all but stopped our communication with the lodges by Postal mail. Our primary means of communication must be through Grandview and email.

The Grandview system, when utilized as it should be, will reduce the workload of the lodge secretary as well as the Grand Lodge staff. I commend the lodge Secretaries and Masters who have encouraged their membership to use Grandview. Grandview has many other tools that can further save lodges and the Grand Lodge time and money, but only if we can simply get our members and lodge secretaries to use Grandview. Many Grand Jurisdictions have made the use of Grandview mandatory by their lodges and as a result now have close to 100% of their membership fully participating!

Grandview is not just a Grand Lodge tool, it is your tool. For lodge Secretaries, it can replace all that manual record keeping, including monthly and annual reports! There are tools to account for dues collection and a myriad of reports to manage membership. The Posts and Events features can be used to inform the membership about things going on in the lodge. Each member can update their own record with contact information and other personal information. Members have access to the Feed tool on the lodge portal which can be used like other social media, but is unique to the lodge. Those that are currently fully utilizing this tool can attest to its benefits.

## <u>Building</u>

The expense of maintaining our building continues to grow each year. As I stated above, the Trustees have been forced to defer all but emergency maintenance because of budget restrictions. Some of the

items needing attention are upgrading or replacing the HVAC control system and adding building security along with a host of more minor issues in the interior of the building. The building is not ADA compliant and many of our brethren who are limited in their ability to move are unable to visit the building.

W.: Bryan Shackelford continues to volunteer his time to perform general maintenance and most often pays for parts and materials out of his pocket. Once again, we are expecting volunteers to supplement Grand Lodge operations by spending their own money. Our heartfelt thanks goes out to him for all he has done and continues to do. And to

#### **Membership**

We closed 2022 with a total of 18,705 members including 1,565 plural members resulting in 17,140 living Master Masons. As of September 26, 2023, that number is 17,188 members with 1,565 of them plural, or 15,623 Master Masons. This a loss of 1,517 members. Of this total, we currently have 9,669 Perpetual Members, resulting in 5,854 dues paying members. Following the trends, it is possible that we could experience another 1,200 or more losses in the coming year. Since the current per capita rate is only charged to the dues paying members in each lodge, as membership drops so does the total amount of per capita the Grand Lodge receives as Revenue.

As previously reported, Suspensions for Non-Payment of Dues (NPD) continues to be a preventable loss. From November 1, 2022 through September 26, 2023 we suspended 360 brethren for Non-Payment of Dues. Sadly, from November 1, 2022 through September 26, 2023 we lost 413 brethren passing to that House Not Made With Hands.

## Secretary Workshops and Other Training Programs

We conducted three Secretary Workshops this year, one each in Oklahoma City, Tulsa, and Eufaula. The workshops were well attended with 121 participants. We have already scheduled a session in Tulsa and another in Oklahoma City in January of next year.

The Grand Master conducted one Leadership/Mentorship Workshop this year. Participation was great with over 50 individuals attending. One of the Grand Master's major projects this year was the "Middle Chamber" educational program. This program consisted of nine daylong sessions, three each at Broken Arrow No. 243, at Oklahoma City No. 36 and at Lawton No. 183. Each session was a full day focusing

on each of the three degrees. The Grand Secretary's office provided adminstrative support to each of these sessions.

It is noteworthy that in an effort to increase attendance the fees for all Grand Lodge training progams is structured to recoup only the actual costs for the training materials.

#### Conclusion

I have always belived that primary duty of the Office of Grand Secretary and the office staff is one of service; service to the lodges and maybe more importantly, service to the Masons in this jurisdiction. This year each and every one of us in your Grand Lodge office have worked very diligently to do just that. I hope we have met your expectations.

An additional focus this year was to reduce operational cost everywhere we could and watch over every dollar as if it were our own. I believe we have met that expectation.

The Lodge Secretaries are the driving force behind their respective lodges. Being a lodge secretary is not an easy job, and each of you need to be commended on your efforts. I especially appreciate those secretaries who are avid Grandview users. Thank you sirs! Unfortunately, we still have those well intentioned brethren in this fraternity that feel the "old" way is the best way, even if maintaining the status quo results in additional cost. We as a craft must make continual changes to ensure the craft survives.

My thanks M :: W :: Chaney, Grand Master, Deputy Grand Master John Carter, Grand Wardens James Roderick and Don Stanton, Grand Treasurer David G. David and M :: W :: Bob Peters, Grand Lecturer. We encountered a number of bumps in the road along the way this year as we continue to deal with decreasing budgets and many other issues and with your patience and assistance we worked through every one. I have enjoyed serving with this wonderful group of men. My thanks sirs and I look forward to serving with the incoming Grand Lodge officers.

And finally, thanks to my wife Karen, who has been my side for 34 years and never once objected to single thing I wanted to do, but was always eager to help in any endeavor I undertook. If we have had any success in the Grand Lodge office this past year, it is due in no small part to the skill and caring that Karen brought to job. She loves this fraternity and evey member of it. Her impact on the office of the Grand

Secretary and to craft of Oklahoma Masonry will long out live most of us here today. I often remark that I think the craft elected me to get Karen. If that is so, then you made a great choice. We look forward to continuing our service.

## Report of the Grand Lecturer

To the Most Worshipful Grand Lodge Ancient Free and Accepted Masons of the State of Oklahoma

#### Brethren:

This is my second report as your Grand Lecturer. I want to express my sincere thanks to the Grand Lodge Officers, the Deputy Grand Lecturers and assistants, the District Deputy Grand Masters, the Certificate Lecturers Association, the office staff, and the craft at large for your assistance and support throughout this year.

The Deputy Grand Lecturers have done an outstanding job holding District Schools of Instruction. For the period beginning November 12, 2022, and ending September 2, 2023, they have held 33 District Schools and 6 Regional schools for a total of 39 days of instruction with a total attendance of 578.

As of August 31, 2023, there are 2 District Schools scheduled before the 2023 Grand School session.

There are several districts that have not held schools of instruction.

During Grand School, November 2022, a total of 116 Certificate Lecturers signed in. Total attendance for the 3 days was 271. The Board of Grand Lecturers has held 3 meetings at the time of this report, with 1 more meeting scheduled for November 7, 2023, before Grand School.

The regional schools held this year in Atoka, Yukon, Lawton, Shawnee, Broken Arrow, and Sand Springs were a tremendous success. They are attracting more and more participation from across the state. There is an additional regional school scheduled in Alva on September 16, 2023.

There has been a good showing of brothers interested in checking out for the "B" Card certification. To date, we have had 12 new "B" Cards issued. My congratulations to these brothers for their interest and their dedication to our fraternity.

It has been an honor and a privilege to serve this Grand Jurisdiction as Grand Lecturer. You, the Craft of Oklahoma, have made this year a success by attending the schools and helping to perpetuate the adopted work of our Grand Jurisdiction.

## Report of the Masonic Charity Foundation of Oklahoma

To the M.: W.: Grand Lodge of Ancient Free & Accepted Masons of the State of Oklahoma

Most Worshipful Grand Master and Brethren,

The Masonic Charity Foundation of Oklahoma is an Oklahoma not-for-profit corporation formed on July 9, 1930, to encourage charity, benevolence, education, and philanthropy. It was created so Oklahoma Freemasonry's institutional giving could be better focused and coordinated. The activities of the Foundation do not replace those of the individual Masons; they merely serve to supplement them.

#### **MANAGEMENT**

The Foundation is governed by a Board of Directors consisting of twenty-two members. The Most Worshipful Grand Lodge of the State of Oklahoma elects fifteen directors, three each year, for a five-year term. There are also three Directors representing the Scottish Rite, one from each Valley, three Directors representing the York Rite, one from each Grand Body, and one Director from the Order of the Eastern Star. Board members receive no monetary compensation of any kind. The Foundation has full-time staff working in the Edmond office under John L. Logan, Executive Director. The following officers were elected to serve in 2023:

#### **FINANCIAL**

The Foundation's 12/31/2022 combined balance sheet, less the Throckmorton Trust, reflects total assets of \$96,645,221, a decrease of \$17,246,811 from one year ago. Endowments, less the Throckmorton Trust, total \$90,816,030, an increase of \$1,016,555 from one year ago.

#### **LODGE MATCHING FUNDS**

This program was established in 1983 and designed to encourage and support local Lodges in the area of charity by matching local Lodge monetary contributions in scholarships, local disasters, local charitable causes, and local community services. In 2022, 192 Lodges used the program for \$1,502,452. Since the Matching Funds Program began, the Foundation has contributed \$33,316,778 to support local charitable or educational projects. The local lodges' participation has created a minimum of \$66,633,556 of support for local community needs.

Matching Funds dollars have allowed lodges to double their fundraising ability to support local community needs. In 2022, Matching Funds provided an additional \$606,854 in support for youth and public education, \$135,659 to local fire, police, and veterans organizations, \$334,116 to individuals in need (or organizations who provide direct services to needy individuals), \$71,474 to senior citizen centers and charities who provide aid to seniors, \$64,962 to Masonic Youth Orders, and \$47,815 to support local museums, libraries, parks, and historical preservation projects. Matching Funds dollars and lodge fundraising injected over \$2.7 million into community charitable and educational projects.

## PROMISES MATTER

The Foundation stands ready to assist those Lodges and OES Chapters in caring for their needy members through matching funds or direct grants. Each Lodge or Chapter is best positioned to know which members need assistance. Lodges may use their entire \$12,500 matching funds for Promises Matter activities. In 2022, Promises Matter Matching Funds provided an additional \$327,430 to assist female OES and Master Masons members and widows with immediate financial needs due to illness, injury, or other hardship. Also, eight different Lodges received Promises Matter Grants totaling \$33,153. The average grant amount distributed was \$2,763.

The Masonry in Action Award program began in 2013 to recognize lodges that do an outstanding job utilizing the Foundation programs. The Foundation allows each winning Lodge the opportunity to specify a worthy nonprofit in their community to receive a \$5,000 grant. In 2023, Cache Lodge 391 was the small lodge category winner, and Owasso Lodge 545 won the large lodge class for the sixth year. Cache Lodge 391 designated their prize funds to provide a charitable grant of \$2,500.00 for the City of Cache Fire Department and \$2,500.00 for the Indiahoma Fire Department. Owasso Lodge 545 awarded their \$5,000 community grant to an outdoor education program administered by the STEP Survival Foundation. Congratulations to both lodges!

#### **PUBLIC PARTNERSHIPS**

The Foundation works with other organizations to achieve worthwhile goals and make Masonic charity more visible across Oklahoma.

Partners in Prevention is a partnership with Vizavance. Lodges statewide sponsor vision and glaucoma screenings, targeting the young and the elderly. The Foundation granted \$300,000 to support the ongoing costs of the program. Over 140,000 students were screened in the first semester of the 2022-2023 school year. The Foundation has provided over \$5 million to support this important mission, One Goal, One Vision, and One Mission Advancing Children's Education Through Better Vision! Food Bank support has been an annual program since 2011. In 2022, the Fight Childhood Hunger Campaign resulted in \$68,831 donated to the Regional Food Bank and \$31,169 to the Community Food Bank of Eastern Oklahoma. The 2022 Masonic Food for Kids campaign ran from August 1 through October 15. This statewide effort combines the Regional Food Bank of Oklahoma, the Community Food Bank of Eastern Oklahoma, the Masonic Fraternity of Oklahoma, and Griffin Communications (Channel 5 in Oklahoma City and Channel 6 in Tulsa). Food Bank is one of three projects with statewide visibility that attempt to enhance the image of the Fraternity while supporting a significant charitable or educational purpose.

**The Oklahoma State Department of Education -** Our support for public education was demonstrated in nine statewide programs.

1 - The Oklahoma State Teacher of the Year program honors teachers who make outstanding contributions to the public education of our youth. The State Teacher of the Year is awarded a check for \$5,000, and each of the eleven finalists receives

- \$1,000. Each local Teacher of the Year receives a certificate of appreciation.
- 2 The Student of Today Award is a program that encourages outstanding performance in students of all grade levels by recognizing exemplary students. Each recipient receives a certificate, usually from a local Mason, at their school's awards assembly, or some Lodges host banquets for the winners. In 2022, the Foundation prepared 1,792 certificates for presentation.
- 3 Freemasonry uses the Teacher of Today Award program in Oklahoma to say "thanks" to those hundreds of teachers across our state who make a daily difference in our children's lives. Each Teacher receives a certificate presented by the local Lodge. It is a small token to express our appreciation to these men and women who carry the future burden on their shoulders. In 2022, the Foundation prepared 595 certificates for presentation.
- 4 The State Superintendent's Awards for Arts Excellence honor the Fifty top high school seniors in our state's visual and performing arts. Also, the leading school administrators and board members are honored during a prestigious formal reception at the Guthrie Scottish Rite Temple. The students are presented medals by the Grand Master and State Superintendent of Education. The 2023 event will be held at the Guthrie Scottish Rite on April 18, 2023.
- 5 The Payne Education Center is a nonprofit organization established in 1984. Since 1996, the Foundation has supported the Payne Education Center's Reading Readiness program to train kindergarten and transitional 1st-grade teachers by providing scholarships for enhanced reading techniques. In 2022, \$155,000 was provided, \$115,000 was allocated for teacher scholarships, and \$40,000 to support their Digital Phonics Program.
- 6 The Youth Scholarship Program funding is through the Education Endowment. The scholarship program is open to DeMolay, Job's Daughters, and Rainbow members. This year, sixty scholarships of \$3,000 each were budgeted, and forty-three were awarded as follows: DeMolay 9, Job's Daughters 2, and Rainbow 32.

7 - The Senior Essay Contest was launched in 1966 in support of education. Writing teaches critical thinking skills. The essay contest is open to all seniors in Oklahoma public schools. The Masonic Fraternity in Oklahoma sponsors it as part of its continuing commitment to education. Cash prizes in the Men's and Women's divisions range from \$2,000 for 1st place to \$200 for 10th place. Also, a \$5,000 grant will be made to each of the 1st place winners in high school. For the 2022 – 2023 contests, 529 seniors entered the contest. A total of \$13,700 was awarded to the 20 statewide winners of the contest, and \$5,000 grants to the schools of each of the statewide first-place winners. Certificates for presentation to the local division winners of 62 high schools sponsored by 61 Lodges will be provided to the local Lodge.

Senior Assistance Program- Through an agreement with the Oklahoma Area Agencies on Aging, a Department of Human Services division, \$798,146 was given in November 2022 to assist needy Oklahomans aged 55 and over with services not covered by existing government programs during the calendar year 2023. Since the inception of this program in 2007, the Foundation has donated \$11,660,931 in the name of the Masonic Fraternity of Oklahoma to enhance the lives of seniors in our communities. These eleven agencies can be accessed by calling 1-800-211-2116 or at www.okdhs.org.

## CHARITABLE GRANTS

In addition to partnerships with other charitable organizations or agencies, the Masonic Charity Foundation makes several grants yearly to support Public Education, Public Wellness, and Public Charities. Some highlights of 2023 grantmaking are:

- A \$1,000,000 gift will be disbursed in \$500,000 over two years to the Mercy Women's Health Center, which is currently finalizing construction. Due to the tremendous growth in the need for women's healthcare, there is an urgent need to increase the amount of physical space and quality of healing. The new center will offer comprehensive, collaborative care. An essential priority is providing services to the economically disadvantaged.
- Hearts for Hearing provides audiology and speech pathology services in a unique one-stop setting for children with hearing loss. Charitable services for young children ensure they can learn to speak, connect with the world, and become self-sufficient members of their families and communities. A \$200,000 grant

from the Masonic Charity Foundation of Oklahoma will benefit hearing-loss families. In addition to providing the first set of hearing aids to children ten years of age and under at no cost to families, Hearts for Hearing also offers financial assistance for specialized speech therapy and audiology services.

- The Cavett Kids Foundation helps children with terminal or chronic illnesses thrive by using camp experiences to build character, coping skills, and connection. Camps are provided for kids of every age who may be dealing with heart issues, cancer, or other disorders. Masonic charity's \$25,000 camp funding in 2023 will provide two of Cavett's highest-level camp experiences throughout the year.
- The YMCA Military Welcome Center at Will Rogers International Airport provides a safe location for military personnel to rest, access mail and telephone services, find refreshments, and prepare for the journey onward. The Masonic Charity Foundation provided \$18,000 to support the operation of this facility in 2023.

#### SUPPORT OF MASONIC GROUPS

- Each year, the Masonic Charity Foundation supports a charitable or educational cause or project of the Grand Master's choice. In 2022, a \$12,000 grant for equipment was provided to the Arnett High School Science Department STEM program.
- Masonic Charity supports Masonic youth orders! In addition, \$64,449 in Matching Funds was provided to local DeMolay, Rainbow, and Jobs Daughters in 2022. Scholarships of \$3,000 to youth order members and \$10,000 to each youth order's statelevel trust to support ongoing programming and scholarships.
  - The Supreme Assembly, IORG, also received a \$200,000 donation for renovating the Supreme Assembly building in McAlester.
  - Each year, the Masonic Charity Foundation of Oklahoma contributes to the programming of several national Masonic organizations:
  - Gifts totaling \$1 per Oklahoma member are made by the Masonic Charity Foundation every year to support the George Washington Masonic National Memorial in Alexandria, Virginia.

- An annual gift of \$1,500 is made to the Masonic Information Center, an organization operating under the Masonic Service Association of North America that publicly provides information on Freemasons and responds to Freemasonry critics.
- The Masonic Charity Foundation of Oklahoma supports every Masonic Services Association of North America plea for disaster support with a \$1,000 donation.
- Masonic Charity Foundation also provides annual contributions of \$4,000 to the Masonic Service Association of North America's Hospital Visitation Program, making Oklahoma's support of this program competitive nationally.

## Report of the Joint Masonic Fraternal Relations Commission

To the 2023 Officers and Members of the Most Worshipful Grand Lodge Ancient Free & Accepted Masons of the State of Oklahoma

In 2004, our Most Worshipful Grand Lodge Session and the 2005 Most Worshipful Prince Hall Grand Lodge Session each adopted a written Compact, agreeing:

to establish and implement a simple form of Masonic recognition;

- to provide for successful coexistence;
- to ensure a continuing harmonious relationship;

- to promote Masonry in general;
- to have a mutual regard for the right of each Grand Lodge to retain its absolute and supreme sovereignty;
- to memorialize the legitimate right of each to exist and operate within the geographic bounds of the State of Oklahoma; and,
- to secure the blessings of the Grand Architect of the Universe.

Additionally, the above Compact established the Joint Masonic Fraternal Relations Commission (JMFRC), composed of three (3) members from each Grand Lodge who are knowledgeable of the history of the Compact. These members are to meet to consider and make recommendations concerning issues, conflicts, disputes, or questions arising out of the Compact. As of this writing, the JMFRC has held thirty-six meetings since its creation. It is our pleasure to inform this Grand Lodge Session there have been absolutely no conflicts or disputes arising from this Compact between our two Grand Lodges.

In 2008 the Compact was amended by both Grand Lodges to permit tiled visitation among the constituent Lodges of both Grand Lodges.

Therefore, the relationship between our two Grand Lodges is as follows:

The two sovereign Grand Lodges have 100% recognition of each other, as described above.

There is 100% tiled visitation of members among the constituent Lodges chartered by the two Grand Lodges.

There is no plural membership of a member of one Grand Lodge with a Lodge of the other Grand Lodge.

With visitations now occurring between constituent lodges of both jurisdictions, it is especially important that all constituent lodges of our Most Worshipful Grand Lodge observe the Protocol for Visitation, namely a) notification of visitation in advance, b) adhere to dress code of lodge being visited, c) be examined by the lodge you are visiting, and d) examine the brother's dues card. These elements of fraternal protocol will generate good relations between the lodges who are experiencing visitation.

Our Grand Master and other Grand Lodge leaders continue to be received at the annual Prince Hall Grand Lodge Session with a maximum of fraternal courtesy and respect. Our Grand Lodge appreciates these genuine displays of brotherly love and affection. Likewise, the P.H.A. Grand Master and his officers are officially received and welcomed at the annual A.F. & A.M. Grand Lodge session.

There continues to be significant joint interaction between the two Grand Lodges:

Commission members continue to monitor the progress of visitation and potential recognition between the Oklahoma P.H.A. and A.F. & A.M. Order of the Eastern Star organizations.

Commission members note the continued visitation between constituent Lodges of each sovereign Grand Lodges; as well as the continued intervisitation and cooperation at the National level.

On September 7, 2022, a historic Scottish Rite signing of a Unity Statement ceremony was held in Washington, D.C. This was the highest profile and most publicized national unity event that has been held to date.

Discussions continue to implement more Festive Boards where members of each Grand Lodge may join in harmony and fraternal fellowship.

As you can see, the fraternal bonds of Masonry continue to grow between the members of our two Oklahoma Grand Lodges.

## Report of the Grand Lodge Museum and Library

M.W. Grand Lodge AF & AM of State of Oklahoma (Museum & Library), Inc.

Most Worshipful Grand Master and Brethren All,

At its 2022 Annual Communication, Section 707 of the Constitution & Laws of the Grand Lodge was amended to expand the Board of Directors of the Grand Lodge Museum & Library from six to nine members. Additionally,

the Grand Lodge delegates elected five members to the Board to fill new and expiring seats.

On January 18th, 2023, the new nine-member Board of Directors held an organizational meeting at which the four officers of the Board were elected and the chairmen and members of the four standing committees were also elected: Gift Acceptance/Museum, Periodicals/Library, Technology and Strategic Planning.

The following accomplishments for the year have been made by the Board of Directors of the Grand Lodge Museum & Library:

- The Board implemented the Stewardship Capital Campaign with a goal of raising \$300,000 to fund our 10-year strategic plan. To date, over 10% of the goal has been raised thanks to the generosity of Brothers and Lodges.
- The board secured a \$200,000 insurance policy on the artifacts and books in the collection.
- The Board secured a Preservation Assessment of the artifacts in the collection, which was completed in May of this year, along with a grant from the Oklahoma Department of Libraries to pay for the Assessment.
- The Gift Acceptance/Museum Committee continued to review and recommend acceptance of donations presented to the Museum, as well as acquired several items through purchase. The committee developed a template for inventorying the artifacts of the Museum.
- The Board approved a Loan Acceptance policy for items loaned to the Museum and Library.
- The Library Materials Review Committee made several book acquisitions and accepted book donations from members of the Craft.
- The Technology Committee continues to utilize the Facebook page to increase the exposure of the Museum and Library. The committee also brought the Museum & Library website online and continues to enhance it.
- Members of the Board participated in the Grand Lodge Open House on July 1st offering tours of both the Museum and Library and answering questions for the attendees.

#### The 2023 "Yellow Book"

- The Board continued its membership in the Masonic Library and Museum Association. Board members participated in last year's virtual annual conference.
- The Bylaws were revised to clarify how vacancies would be filled on the Board and to remove of the Past President as an officer of the Board.

As an information sharing practice, a Grand Lodge Museum & Library quarterly financial report is forwarded to the Grand Secretary for dissemination to the Grand Lodge Trustees and the Committee on Jurisprudence.

The Board wishes to thank those individuals, lodges, and organizations that have contributed to the Stewardship Capital Campaign. It is only through the donations of the Craft that we will be able to see our strategic plan through to its completion.

The Board also wishes to express its thanks to Grand Master Chaney and the Grand Lodge Trustees for their continued support this past year.

This continues to be an exciting time in the life of the Grand Lodge Museum and Library. The Board wishes to encourage the Craft's involvement and participation.

## Fraternal Correspondence and Relations Committee

To the Most Worshipful Grand Lodge Ancient Free and Accepted Masons Of the State of Oklahoma

Most Worshipful Grand Master, Distinguished Grand East, and Brethren all:

The Committee serves two purposes on behalf of the Grand Lodge of Oklahoma. We report on the condition and actions of Grand Lodges with which Oklahoma is in fraternal relationship and handle all matters pertaining to fraternal correspondence. The committee members address the first purpose, and the Grand Secretary addresses all fraternal correspondence.

Each year, Grand Lodges are faced with requests from foreign jurisdictions to be recognized by the regular Grand Lodges throughout the world. These inquiries are generally facilitated by the Commission on Information for Recognition, which was organized in 1951 by the Grand Master's Conference of North America.

The guidelines used to evaluate the regularity of a grand lodge, and to determine whether it is worthy of consideration for recognition by our member Grand Lodges include the foundational standards of the fraternity concerning recognition. These standards are:

Legitimacy of origin.

- Exclusive territorial jurisdiction, except by mutual consent and/or treaty.
- 2 Adherence to the Ancient Landmarks specifically, a Belief in God, the Volume of the Sacred Law as an indispensable part of the Furniture of the Lodge, and the prohibition of the discussion of politics and religion.

The Commission is only an advisory Body. It is up to each Grand Lodge to decide on matters of recognition. This report summarizes the requests that have been made and the counsel given to the North American Grand Lodges by the Commission in February 2023

## The Ancient and Accepted Scottish Rite of Bulgaria

The matter of regular Freemasonry in Bulgaria has repeatedly been addressed by the Commission (see 2008-2013 and 2015-2016, particularly 2016 and the supplement to 2008). The United Grand Lodge of Bulgaria has been determined to be a regular grand lodge. We see no reason to change this finding. The Grand Lodge of the Ancient and Accepted Rite of Bulgaria does not appear to meet the standards of recognition.

## **Grand Lodge Equinoccial of Ecuador**

A majority of grand lodges recognize the Grand Lodge of Ecuador, AF&AM, founded in 1921. In 2022, the Grand Lodge Equinoccial of Ecuador requested findings that they met the standards of recognition in 2022. At that time, the Commission did not have evidence of an agreement or treaty to share the jurisdiction of Ecuador. A presentation was made to the Commission on February 19, 2023, by Equinoccial. The Grand Master of the Grand Lodge of Ecuador, AF&AM, also appeared. He stated that the two grand lodges have been talking and that in the future they may sign a treaty of mutual recognition. At this point, there is no treaty. Inasmuch as there is no treaty to share the jurisdiction, it does not appear that the Grand Lodge Equinoccial of Ecuador meets the Standards of Recognition.

## Grand lodge of Georgia, A.F. & A.M. (the country)

In 2022, the Commission set out facts regarding the grand lodges in the country of Georgia. The Grand Lodge of Georgia, AF&AM was formed in 201S. The United Grand Lodge of Georgia (UGLG) was formed in 2018. Last year UGLG sought a finding that they met the Standards of Recognition. Numerous questions were raised by the Commission, including the existence of the 2015 A.F.&A.M. Grand Lodge of Georgia. The Commission was told that the 2015 grand Lodge was no longer in existence. The Commission found that the documentation failed to demonstrate that UGLG met the Standards of Recognition adopted by this Conference. The 2015 AF&AM Grand Lodge is now before us seeking a finding that it meets our Standards of Recognition. Representatives of both grand lodges appeared before the Commission on February 19, 2023. This year, the UGLG alleges that the Grand Master of Georgia AF&AM was present in Cologne in October 2016, when the decision to form the UGLG was made, and that he consented to the formation of the new grand lodge. AF&AM of Georgia responds that this Grand Master was expelled from Georgia AF&AM on May 30, 2016, before the October 28, 2016, Cologne meeting occurred, and he therefore had no authority. Further, the AF&AM Grand Lodge never voted to merge. Additionally, it was reported that the Grand Lodge of Russia was informed of the expulsion of the AF&AM grand master prior to the Cologne meeting. The AF&AM of Georgia reports seven lodges currently working, and that at least three AF&AM lodges have continued to work since 2015. The UGLG Grand Chancellor represented his Grand Lodge Commission. He did not address whether the AF&AM Grand Master was expelled by AF&AM of Georgia. UGLG had no proof that the existing AF&AM Grand Lodge of Georgia ever approved the merger into or with UGLG.

The Commission again notes the issues with the 2018 charter issued to UGLG. Consequently, the Commission sees no reason to change its opinion of 2022 regarding the 2018 UGLG. Indeed, there is now even greater evidence supporting that finding. Based on the facts presented to us, it appears the Grand Lodge of Georgia, AF&AM, founded in 2015, meets the Standards of Recognition.

## Grand Lodge of Lebanon, F. & A.M.

In 2022, the Grand Lodge of Lebanon, F&AM sought a finding that it met the Standards of Recognition. The Commission declined to make findings at that time. The Grand Lodge of Lebanon has returned, asking that we issue "a clear statement of finding about the regularity" of the Grand Lodge of Lebanon. The Grand Lodges of Scotland, Washington, D.C., and Grande Loge Nationale Frances have responded at length, arguing that the Grand Lodge of Lebanon was not begun in a regular manner. At presentations on February 19, 2023, the following facts regarding the founding of the Grand Lodge of Lebanon appeared established: There were three New York lodges listed as founding the Grand Lodge of Lebanon: Ani. Fakhrudin, and Chouf. No minutes from these lodges have been provided showing the lodges approved of the new grand lodge. No minutes of an assembly or convention of Freemasons have been provided showing the masons of Lebanon approved the founding of a new grand lodge. Importantly, after the formation of the new grand lodge, the three lodges said to have founded the Grand Lodge of Lebanon actually requested and received new charters from the Grand Lodge of New York, keeping the same names they had as lodges under the Grand Lodge of New York and subsequently Lebanon. Based on the facts presented to the Commission, the Grand Lodge of Lebanon does not appear to meet the Standards of Recognition. We hope the Freemasons residing in Lebanon will continue to seek the Freemasonry they envision for their country.

## **Grande Lodge Nationale Togolaise**

There is a division in this grand lodge under two grand masters: Clomegah and Pessinaba. In 2019, the Conference of Regular African Grand Lodges determined that Ignace Clomegah was the legitimate grand master. The Commission declines to make any findings regarding the conflict.

## **National Grand Lodge of Romania**

We have been advised that individuals claiming to be officers of the National Grand Lodge of Romania have appeared at a regional masonic conference, seeking to "reconfirm" existing treaties of recognition. It is noted that they have a similar, but different coat of arms on their letterhead. The National Grand Lodge of Romania advises that they are not seeking to reconfirm existing treaties of recognition. The Grand Master of the National Grand Lodge of Romania is Radu Balanescu.

#### Grand Orient of the State of Mato Grosso

The Grand Lodge of Oklahoma received a request in 2021 for recognition from the Grand Orient of Mato Grosso. There are four Grand Orients in Brazil. The Grand Oriente do Parana, the Grand Oriente do Santa Catarina, the Grand Orient do Rio Grande do Sol, and the Grand Oriente do Mato Gross. All four are recognized by treaties which were signed with their respective State Grand Lodges in August/September of 2016. Each of these Bodies are now recognized by the Commission on Information and Recognition. It would be reasonable to assume that these Grand Orients are practicing regular Masonry.

#### Masonic Education Committee

Most Worshipful, Right Worshipful, and Worshipful Sirs:

The Grand Lodge Education Committee would like to thank those brothers who have signed up on Grandview with a willingness to deliver Masonic education programs when requested by lodges. It has often been said that the only thing standing in the way of Masonic education in Oklahoma is not knowing brothers who are willing and able to provide it.

We know that Freemasonry has many legitimate and important facets. We are fraternal. We are charitable. We are civic-minded. These are all worthy endeavors. Of the three principal tenets of Masonry's profession—Brotherly Love, Relief, and Truth—the one thing we have not focused on since the 19th century is the third element of Truth. This is the missing link in our time that once set Freemasonry apart from all other organizations. It is why we were founded as a ritual based institution. It is the reason every lodge is charged with maintaining ritual competency. We are a degree conferring body. And hidden within the language of our ritual is much spiritual and philosophical truth. It is in our understanding of that which is allegorical which transforms us for the better as men.

Our Grand Master this year created what is becoming a popular undertaking in American freemasonry. It is styled the Middle Chamber. This program is designed to be the cornerstone for introducing members to the spiritual and philosophical aspects of our ritual. It is an attempt to give spiritual water to a long-neglected flower in the garden of the Craft. This program focuses on the third tenet—truth—and attempts to bring it into equal footing with the other more prominent tenets. The Grand Master charged the Grand Lodge Education Committee with developing the intricate details of the program.

This year, the program was conducted in three locations—Oklahoma City, Lawton, and Broken Arrow. A full day was spent at each location focusing on one of the three Symbolic Degrees; making a total of nine presentations. The first truth the 75 members who enrolled in the program explored this Grand Lodge year is that our ritual is veiled in allegory and illustrated by symbols. Not every teaching of Masonry is dependent on understanding the power of this phrase, but the work of the Middle Chamber is fundamentally tied to it. The "veiled in allegory and illustrated by symbols" reference introduces the Masonic student to an alternative path of interpreting and understanding the ritual, and profoundly reinforces the importance of our ritual instruction.

The Middle Chamber program provides a map for each brother's personal hero's journey. The program will be available again in 2024. The Grand Lodge Education Committee invites every Master Mason to travel with us on this unique and meaningful quest. It is our inner quest for awakening consciousness, for personal and spiritual development as men.

After all, this was the vision of our founding fathers. There is not another organization in the world that offers this level of inner work for the man who truly wants to become a Master of his craft, and a more enlightened human being. If this is compelling to you, then we invite you to participate with us, as we pursue this holistic journey together as more enlightened and spiritual men.

## Strategic Planning Committee Report

The Grand Lodge Strategic Planning Committee was organized to develop a true and verifiable assessment of the condition of Masonry in Oklahoma so that the systemic, structural, and cultural issues facing the fraternity could be addressed, and initiatives proposed to reconcile them. The plan has been distributed and discussed across the State. The purpose of the committee is to develop action plans for the Grand Lodge and its constituent Lodges which address the 16 initiatives laid out in the plan in order to prevent the demise of the fraternity over the next few decades.

Since the plan's adoption in 2019, the productivity of Oklahoma lodges in creating new Master Masons has continued to decline annually at a concerning rate. The lack of a committed and sustaining effort over a long period of time focused on growth and vitality has resulted in a disproportionate generational distribution of men in their declining years.

The active participation in a majority of lodges has fallen to a level where local Masonic leaders are no longer focused on acquiring new members or maintaining adequate degree proficiency to confer the Masonic degrees. It has also become evident that too many of our lodges presently see themselves as a charitable organization instead of a fraternity. The focus is on helping organizations in the community rather than helping our own organization.

Statistically projecting the declining participation numbers in lodges, the age distribution of active participants, and the mortality rate reveals that 62 Oklahoma lodges will close their doors before the end of this decade.

One of the Grand Master's focuses this year is the attention he has given to the critical importance lodge consolidations will have on the future of Oklahoma Masonry. He is aware of the liability the Grand Lodge will inherit by lodges going defunct rather than consolidating. By disposing of property, combining assets and membership through a strategically planned consolidation program going forward, is the most practical way of sustaining and rebuilding our fraternity across the vast rural areas of our Grand Jurisdiction.

The Grand Master is to be commended for facilitating and aiding the consolidation of 7 lodges this year.

The Committee encourages those lodges who are under threat of closure to make consolidation a high priority next year, and in the years that follow. We can only build a future in active, viable lodges. The path of consolidation will lead to this result.

WHEREAS, Section U301 authorizes Lodges to establish and charge Annual Dues to their members, which, obviously must be a minimum sufficient to pay the Grand Lodge per capita amount and support the financial needs of the Lodge, and,

**WHEREAS,** Poor drafting of current statute in the Constitution and Code has referred to Lodges paying dues in some places, and lodges paying dues and per capita in other places, and,

**WHEREAS**, This confusion in the Constitution and Code can be eliminated.

NOW THEREFORE BE IT RESOLVED THAT, Section U 301, which now reads:

**SECTION U 301. BYLAWS OF CONSTITUENT LODGES:** All Constituent lodges will have a set of bylaws. Such Bylaws must specify the name, place of meeting, days and times of stated meetings, fees for each degree and annual dues.

#### **BE AMENDED TO READ:**

**SECTION U 301. BYLAWS OF CONSTITUENT LODGES:** All Constituent lodges will have a set of bylaws. Such Bylaws must specify the name, place of meeting, days and times of stated meetings, fees for each degree and annual dues in **an amount to include lodge support and Grand Lodge per capita.**

#### RESOLUTION NO. 2

**WHEREAS,** Each lodge has unique financial needs based on salaries, utilities, building maintenance, rent, etc., and,

**WHEREAS**, Section U 419, setting a minimum dues amount in Oklahoma at \$20.00 is woefully out of date, since the amount of \$20.00 does not even cover the present day per capita, and,

**WHEREAS,** The Grand Lodge cannot determine the individual lodge financial needs,

**NOW THEREFORE BE IT RESOLVED THAT**, Section U 419, which reads, in part, as follows:

**SECTION U 419. FEES AND DUES:** Each constituent lodge shall fix the fees to be charged for the degrees. The fees for the three (3) degrees shall not be less than \$60 (sixty dollars) in addition to the Entered Apprentice contribution of \$15 (fifteen dollars); but it may, at its discretion, charge more. It may also fix the amount of annual dues to be charged its members but said annual dues shall not be less than \$20 (twenty dollars).

#### BE AMENDED TO READ:

SECTION U 419. FEES AND DUES: Each constituent lodge shall fix the fees to be charged for the degrees. The fees for the three (3) degrees shall not be less than \$60 (sixty dollars) in addition to the Entered Apprentice contribution of \$15 (fifteen dollars); but it may, at its discretion, charge more. It may also fix the amount of annual dues to be charged its members to include lodge support and Grand Lodge per capita, but said annual dues shall not be less than \$20 (twenty dollars).

## **RESOLUTION NO. 3**

**WHEREAS**, Lodges have the right to remit the dues of a member in financial hardship, and,

**WHEREAS**, Section U 424 identifies two (2) allowable justifications for exemption from Grand Lodge per capita, and,

**WHEREAS**, Poor drafting of current statute in the Constitution and Code has referred to Members paying dues in some places, and paying dues and per capita in other places, and,

WHEREAS, This confusion in the Constitution and Code can be eliminated,

NOW THEREFORE BE IT RESOLVED THAT, Section U 424, which now reads:

**SECTION U 424. MEMBERS UNABLE TO PAY:** On notice of a member's financial hardship, the Master shall appoint a committee to ascertain the members ability to pay. Upon report of the committee, the Master will put the question to the lodge for a vote to remit the dues of the brother in hardship. This remission of dues shall be valid for one (1) Masonic year and this process may be repeated on an annual basis, if required. All Master Masons in a long-term nursing care facility shall be exempt from all dues, and Grand Lodge per capita. No member shall be exempt from dues for any other purpose unless the lodge pays the Grand Lodge per capita.

BE AMENDED TO READ: SECTION U 424. MEMBERS UNABLE TO PAY: On notice of a member's financial hardship, the Master shall appoint a committee to ascertain the members' ability to pay. Upon report of the committee, the Master will put the question to the lodge for a vote to remit the dues of the brother in financial hardship. This remission of dues shall be valid for one (1) Masonic year and this process may be repeated on an annual basis, if required.

The lodge must still pay per capita to the Grand Lodge if the member's dues are remitted for any other reason.

All Master Masons in a long-term nursing care facility, assisted living facility, Hospice care, or when medically confined to his home, shall be exempt from all dues. and Grand Lodge per capita. No member shall be exempt from dues for any other purpose unless the lodge pays the Grand Lodge per capita. Lodges shall report the long-term care facility name and location to the Grand Secretary on a form provided by the Grand Lodge.

#### RESOLUTION NO. 4

**WHEREAS,** Due to lower membership attendance in many Oklahoma Lodges, a new member is thrust into elected leadership of his Lodge, making him a Past Master, and technically eligible for Grand Lodge elected office, with only 2-4 years of Masonic experience, and,

**WHEREAS,** The office of Grand Master or Grand Lodge trustee requires the holder to make decisions physical and financial, which directly concern the Craft of Oklahoma, and

**WHEREAS:** The person elected to the Grand Line will be Grand Master, and be charged with interpreting the Constitution, Laws, Uniform Code and Trail Code of this Grand Jurisdiction, and,

**WHEREAS,** The knowledge and understanding the decisions and interpretations of our laws and rules, as well as the Fraternity's customs, history, and usages, can only be obtained by a working knowledge of the Fraternity, and,

**WHEREAS,** In order to have time to acquire a thorough knowledge of the Fraternity, it is necessary to require a minimum number of years of service before being eligible for elected Grand Lodge service.

THEREFORE, BE IT RESOLVED: that Section 105 paragraph 1, which now reads. SECTION 105. ELIGIBILITY FOR OFFICE: No member shall be eligible to an office in the Grand Lodge or on any of its committees or boards unless he is a present Master or a Past Master and a member of a constituent lodge of this Grand Jurisdiction. No member shall be eligible to be elected to serve on more than one Grand Lodge elected Board of Directors or Trustees at a time. No member shall be eligible for the Office of Grand Master or Deputy Grand Master of this Grand Lodge unless he shall have been previously elected and served as a Grand Warden of this Grand Jurisdiction.

#### **BE AMENDED TO READ:**

**SECTION 105. ELIGIBILITY FOR OFFICE:** No member shall be eligible to an office in the Grand Lodge or on any of its committees or boards unless he is a present Master or a Past Master and a member

of a constituent lodge of this Grand Jurisdiction. In addition to the above, no member shall be eligible to be elected as a Grand Lodge officer unless he shall have been a Master Mason at least twelve years on the date of his election.

No member shall be eligible for the Office of Grand Master or Deputy Grand Master of this Grand Lodge unless he shall have been previously elected and served as a Grand Warden of this Grand Jurisdiction.

No member shall be eligible to be elected to serve on more than one Grand Lodge elected Board of Directors or Trustees at a time.

WHEREAS, Lodges and Lodge officers tend to rely on the Grand Master to assist in such matters via the legal exercise of his power and authority,

#### SECTION 202. GRAND MASTER

**B. POWERS:** When the Grand Lodge is not in session he shall exercise all its powers, except the granting of charters:

He shall have power:

4. To suspend the Master of any lodge from the exercise of the power and duties of his office, for good reason appearing to him, until the next annual communication of the Grand Lodge.

#### BE AMENDED TO READ:

#### **SECTION 202. GRAND MASTER**

**B. POWERS:** When the Grand Lodge is not in session shall exercise all its powers, except the granting of charters:

4. to suspend the Master of any lodge and/or any of its elected officers, from the exercise of the power and duties of his office, for good reason appearing to him, until the next annual communication of the Grand Lodge.

#### RESOLUTION NO. 6

**Whereas,** A brother may be suspended for nonpayment of dues, creating a gap in his Masonic record for years of membership, and,

**Whereas,** The brother's suspension may be the result of circumstances beyond his control, and,

**Whereas,** This gap may become significant enough to prevent a brother from obtaining their 50-year pin as would have occurred had the brother not been suspended, and,

**Whereas,** There is currently no method provided to allow a brother to make up for those lost years of membership, and,

**Whereas,** These years of suspension represent a loss of revenue for the lodge reducing their ability to meet financial obligations, and,

**Whereas,** The Grand Lodge also incurs a loss of per capita revenue for these years.

Now Therefore be it Resolved that a new Section of the Uniform Code be created as follows:

A member may buy back suspended years for non-payment of dues by following these procedures: The member must first be reinstated, after which, the lodge may, upon majority vote, allow the brother to pay dues for all the years of his suspension at the current annual dues rate of the lodge. The reinstated member will then be given credit for said years of suspensions. This provision does not apply to a brother suspended for any reason other than non-payment of dues.

**Whereas,** Section 805 of the Miscellaneous Provisions of the Constitution and Laws specifies a waiting period of 6 months to petition other Masonic Bodes, unless the Master Mason proficiency has been passed, and

**Whereas**, It has become common practice in recent years for incoming Oklahoma Grand Masters to waive this requirement of the Constitution and Laws by numbered "Decision", and

**Whereas,** Grand Master "Decisions" ought to be reserved for matters of the utmost urgency in cases where time constraints make consultation with the craft impractical, and

**Whereas,** The nature of a Grand Master "Decision" does not permit or allow thousands of Oklahoma Masons who form the craft to provide their input into such a consequential matter concerning their fraternity, and

**Whereas,** A resolution submitted at an annual Communication of the Grand Lodge would provide such input from the craft for the consideration of future Grand Masters prior to making a "Decision."

Now, therefore be it resolved that Section 805 which currently reads: PETITIONING OTHER CONCORDANT SECTION 805. ANDROGYNOUS BODIES: It shall be a Masonic offense to solicit an Entered Apprentice or Fellow Craft to petition for the degrees of such other Concordant or Androgynous Bodies. A Master Mason shall not petition for the degrees of such other Concordant or Androgynous Bodies until six (6) months after the date of his becoming a Master Mason or he shall have passed his proficiency in the Master Mason degree. It shall also be a Masonic offense for an Entered Apprentice or Fellow Craft to attend a closed meeting of a recognized Appendant Body, unless he is otherwise permitted to attend the closed meeting pursuant to the rules of the Appendant Body.

#### BE AMENDED TO READ:

**PETITIONING** CONCORDANT SECTION 805. OTHER OR ANDROGYNOUS BODIES: It shall be a Masonic offense to solicit an Entered Apprentice or Fellow Craft to petition for the degrees of such other Concordant or Androgynous Bodies. A Master Mason shall not petition for the degrees of such other Concordant or Androgynous Bodies until six (6) months after the date of his becoming a Master Mason or he shall have passed his proficiency in the Master Mason degree. It shall also be a Masonic offense for an Entered Apprentice or Fellow Craft to attend a closed meeting of a recognized Appendant Body, unless he is otherwise permitted to attend the closed meeting pursuant to the rules of the Appendant Body.


