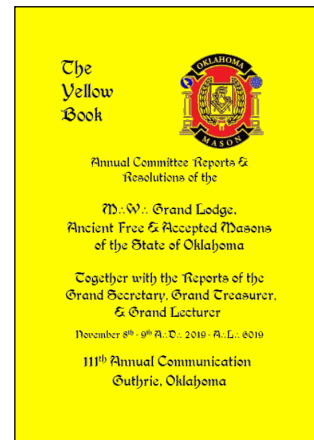
in the 2019 Grand Lodge proceedings.

From the Senior Grand Warden:

One of the great benefits of the Internet in our time is that all communication is now ubiquitous; that is, any topic you can imagine to know something about is now available at your fingertips, regardless of where you live. This has opened Masonic communication to a global audience. With the click of a mouse, we can know what is taking place in our fraternal order from Australia to Denmark; Alaska to Japan; and every point in between.

For the first time in the history of Freemasonry, acquaintances with brothers are being made every day on a global scale. Friendships are being forged, the brotherly hand of fraternal love is being extended, and we are learning a great deal about how Masonry is being practiced all over the world. We can examine membership trends, discover who the Masonic heroes have been in foreign jurisdictions, and inquire into why men join and what their expectations are in the fraternal culture in which they live.

We are learning that Freemasonry is actually growing in a surprising number of countries outside North America; and has been growing for a couple of decades. It begs us to inquire what is different about the Masonic experience in these other places? Since the ceremonies of the degrees are not unlike our own, Masonic halls are arranged in very much the same way. Men convene under very much the same rules and obligations, and a Volume of Sacred Law is always open when brothers meet, assuring us that what Masons do everywhere is centered around the Grand Architect. What, then, is the difference that enables Freemasonry to grow in some places and decline in others? It is a question that indeed begs our attention since Masonry in our own American

Grand Lodges, with one or two exceptions, has not enjoyed a single year of growth in the last 60 years.

Granted, it is a problem we haven't had to worry much about until recently because there were an adequate number of members in most lodges to keep the bills paid and the fraternal experience afloat. We were losing members each year but we still had plenty of regular lodge attendees to carry on the work. Fortunately, we still have a faithful core of brothers in a number of our lodges who are there at every meeting, sharing in fellowship, and content that Masonry is still available to them.

We tend to lose sight of the fact that we have lost over 60% of the lodges that ever existed in Oklahoma. We have lost 80% of the members we had in 1959. Nationally, in that year, Freemasons represented 4.8% of the US male population. Today, we represent less than 1%

(.006%) of the US male population.

It is estimated that, in ten years, Freemasonry will be where the Odd Fellows are today. How many Odd Fellows do you know? How many Odd Fellows halls are you aware of across our State? There was a time when the Odd Fellows were the largest fraternal society in America.

Maybe it's time that we all take a look at what is causing Freemasonry to grow in other parts of the world? What are our European and South American brothers doing that we can emulate to get us back on the path to renewal and growth? Maybe there are some things we can learn from our foreign brothers that we can emulate in our own fraternal experience. Maybe we need to rethink how we have got to where we are since 1959 and make the adjustments we need to make to stop this stubborn 60- year downward trend. Our future is literally in our hands.

You probably know by now that the Grand Lodge is undertaking a Strategic Plan under the able direction of Grand Master Dixon. We have already made a number of discoveries which can help us get on a path of eventual renewal and growth. We have a real opportunity to turn this thing around! There is much more work to be done, of course, but we believe with all our hearts that our members can turn Oklahoma Masonry around over the next 20 years. It is time for all of us to roll up our sleeves and go to work on our own success. We believe that most of you want Freemasonry to be around for generations to come. Let's work together to make this happen!

The State Wide Forums have concluded and valuable information has been gleaned from these meetings. A report is being constructed and will soon be available to the Craft. We have had some great input and ideas that have been brought forth at these forum meetings.

While sitting here and thinking over all these, I had a thought come to mind. The thought was — we have all this information and have discussed and cussed it, but the one thing we lack is ACTION. That seems to be the norm in our Fraternity. We talk and hash on the subjects that we feel are important to the Fraternity or even our Lodge, but it seems the common denominator to these are the lack of or the slow pace of action.

Brothers, if we want OUR Fraternity to survive and thrive, **COMMUNICATION AND ACTION** are the keys to survival. A good place to start Communication and Action, is at the Lodge level. Contact ALL the Brothers when there is a function going on from Stated Meetings, Practices, Family Nights, Friends Nights and even planning meetings. This includes the Brothers that are attending every meeting to the ones who haven't attended in five years. Begin at this fundamental point and you can build from there. Always remember that what you do —**Communication and Action**— are the keys to going forward.

The line of communication has been set up and put into action through the State Wide Forums and Leadership Workshops. These two assets are like voting. If you did not attend them then your voice is not heard. The first step towards communicating has been taken. Now let's keep this an ongoing process and participate. Remember, if you are not part of the solution, you are the problem.

Grand Lodge and Grand School is another tool towards achieving **Communication** and **Action**.

In our Fathers' and Grandfathers' days, attending Grand Lodge was a duty. That is the how we should be viewing Grand Lodge today. At Grand Lodge, ideas and concerns for our Fraternity can be addressed between Brothers and brought to your Grand Lodge Trustees' attention. Remember, Brothers, the Trustees were elected by the Craft to take care of and operate the Fraternity for the **Good of Masonry**. However, the operation of a body is only as good as the information that is available. Your attendance at Grand Lodge is a starting point for the communication of the Fraternity. Remember, if that idea or concern stays in your head and is not communicated, **it goes nowhere**, so come to Grand Lodge.

If you are a Worshipful Master, Senior Warden, Junior Warden, or Past Master, you have a vote. It is your duty to the Fraternity and your Brothers to exercise this vote on behalf of the Fraternity. Do you realize there are a mere 150 Brothers carrying the deciding votes to elect or reject an idea presented. It is time that changes. If your Fraternity is to survive and progress in the direction you feel it should be going, let's start now in November 2019 by you coming to Grand Lodge and communicating and taking action with the Brothers.

Another great opportunity to come to Grand Lodge is Grand School. I have heard that the ones who come to Grand School, or any School for that matter, don't need it, and the ones that do need it, don't come. That, Brothers, is the biggest misconception I have ever heard. Everybody needs School. All Brothers need refreshment in knowledge, no matter who they are. The fellowship with other Brothers from around the state is priceless. You not only gain a new friend but you can also get ideas and thoughts you can take home to help your Lodge. School is not just sitting in a room listening to ritual. There are other things that can be learned while attending. Remember, if you want dividends in the future, you have to invest today.

Come to Grand Lodge and Grand School and invest in the future. We have to start somewhere to go forward. Grand Lodge is a good place to begin. It has been said that we could have 1000 Brothers at Grand Lodge. That should not be that big of a challenge for the Masons of Oklahoma.

Resolution No. 1

WHEREAS, since the "Official Cipher Key Oklahoma Masonic Ritual" (a.k.a. "Red Book") contains the esoteric work and is therefore only available to Master Masons; and,

WHEREAS, the Entered Apprentices and Fellowcrafts do not have access to the categorical lectures cipher as printed in the Red Book;

WHEREAS, the Red Book has improved the proficiency of many members. A booklet of each categorical lecture would be another tool to help EAs and FCs improve their proficiency and,

WHEREAS, it is in the best interests of the Fraternity to use all means available to advance members to the Sublime Degree of Master Mason.

BE IT THEREFORE RESOLVED that Section 401, which currently reads:

ARTICLE IV - WORK OF THE GRAND JURISDICTION SECTION 401 ESOTERIC WORK: The esoteric work of this Grand Jurisdiction shall be that adopted by this Grand Lodge and shall be used by all its lodges and their members in giving the work and lectures. It shall be in charge of the Board of Grand Lecturers. The Grand Lodge shall publish a two or three letter maximum cipher of all esoteric work of this Grand Jurisdiction. Such cipher shall be used only for teaching. It shall not be consulted in any lodge while at labor. Violation of this section shall be deemed a Masonic offense. Ciphers shall be available to Master Masons through the office of the Grand Secretary

BE AMENDED TO READ:

ARTICLE IV- WORK OF THE GRAND JURISDICTION SECTION 401 ESOTERIC WORK: The esoteric work of this Grand Jurisdiction shall be that adopted by this Grand Lodge and shall be used by all its lodges and their members in giving the work and lectures. It shall be in charge of the Board of Grand Lecturers. The Grand Lodge shall publish a two or three letter maximum cipher of all esoteric work of this Grand Jurisdiction. **The Grand lodge shall also publish two separate cipher booklets, one containing the Categorical lecture for the Degree of Entered Apprentice and one containing the Categorical lecture for the Degree of Fellowcraft.** Such ciphers shall be used only for teaching. # **They** shall not be consulted in any lodge while at labor. Violation of this section shall be deemed a Masonic offense. Ciphers Books shall be available to Master Masons through the office of the Grand Secretary. **Cipher Booklets for the Entered Apprentice Categorical lecture and the Fellowcraft categorical Lecture shall be available to each of the constituent lodges for sale at the cost of the price of printing plus \$5.00 per booklet. The cost of printing shall be rounded to the next dollar. Said booklets may be provided to the Entered Apprentice and Fellowcraft members of the lodge at the individual lodge's discretion.**

THEREFORE BE IT RESOLVED: that Section U 401 which currently reads:

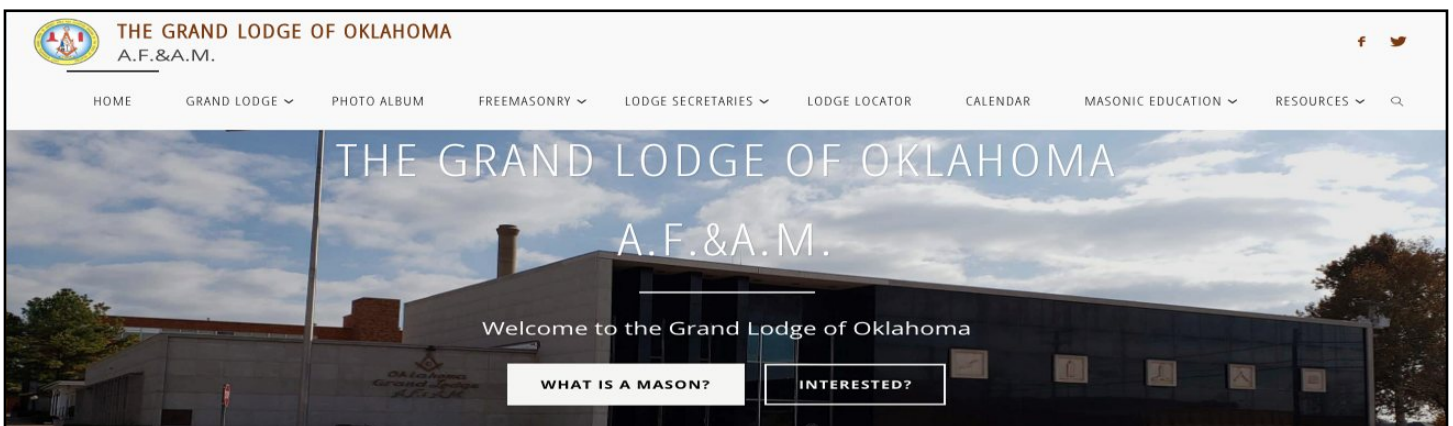

Words From The Craft

The Opening Charge

How many of you have ever heard the Opening Charge? It is in our Murrow Monitor, and may be given after the prayer when opening a stated communication.

Many years ago, when Worshipful Brian Gnad was in the East in Will Rogers Lodge No. 53, my home lodge, where I now serve as Chaplain, he read the Opening Charge at every stated communication. However, since Worshipful Gnad's last meeting as Master, that Opening Charge has not been heard. I would suppose that few lodges make use of that Charge, though I hope I am wrong about that.

This year, I affiliated as a dual member with Collinsville Lodge No. 165. The Worshipful Master, James Roderick, also DDGM for district 11, has his Chaplain give the Opening Charge at every meeting. The Chaplain, Worshipful David Jacobs, does a wonderful job delivering the Charge from memory. During a recent stated communication, David was suffering from laryngitis, and the Master asked me to give the Charge. As I had never taken the time to memorize it, I had to read it. That experience provided me with the impetus to memorize it, should I be called upon in the future to give it.

Let me tell you, nothing helps one focus on the words one is repeating as does memorization. While committing the Charge to memory, I began to realize how important it is for brethren to hear AND contemplate those words.

At the first stated communication of Will Rogers Lodge after I had committed the Charge to memory, I asked the Master if he would permit me to give it, and afterwards, to give a short quiz. With Worshipful John Rossell's permission, I gave the Charge. Since it is not esoteric, I have included it here:

"The ways of virtue are beautiful. Knowledge is attained by degrees. Wisdom dwells with contemplation; there we must seek it. Let us then, brethren, apply ourselves with becoming zeal to the practice of the excellent principles inculcated by our Fraternity. Let us ever remember that the great objects of our Fraternity are the restraint of our desires and passions, the cultivation of an active benevolence, and the promotion of a correct knowledge of the duties we owe to God, our neighbors and ourselves. Let us be united and practice with assiduity the sacred tenets of the Craft. Let all private animosities, if any unhappily exist give place to affection and brotherly love. It is a useless parade to talk of the subjection of our passions the walls of the Lodge, if we permit them to triumph out of the lodge in in our intercourse with each other. Uniting in this great design, let us be happy ourselves and endeavor to promote the happiness of others. Let us cultivate the great moral virtues which are laid down on our Masonic Trestle Board, and improve in everything that is good, amiable and useful. Let the benign genius of the Mystic Art preside over the council and under her sway, let us act with a dignity becoming the high moral character of our venerable Institution."

Following delivery of the Charge, I repeated one line: "Let

us be united and practice with assiduity the sacred tenets of the Craft." I then asked the brethren present, "Who can tell me what the tenets of the Craft are?" Sad to say, I got no answers.

According to the 3rd section lecture of the Entered Apprentice Degree, the tenets of our profession are Brotherly Love, Relief, and Truth. Do you remember the details of those tenets?

Brotherly Love — By the exercise of Brotherly Love, we are taught to regard the whole human species as one family; the high and low, the rich and poor; who, as created by one Almighty Parent, and inhabitants of the same planet, are to aid, support and protect each other. On this principle, Masonry unites men of every country, sect and opinion, and conciliates true friendship among those who might otherwise have remained at a perpetual distance.

Relief—To relieve the distressed is a duty incumbent on all men, but particularly on Masons, who are linked together by an indissoluble chain of sincere affection. To soothe the unhappy, to sympathize with their misfortunes, to compassionate their miseries and to restore peace to their troubled minds, is the grand aim we have in view. On this basis we form our friendships and establish our connections.

Truth — A divine attribute, which is the foundation of every virtue. To be good and true, is the first lesson we are taught in Masonry. On this theme we contemplate, and by its dictates endeavor to regulate our conduct. Hence, while influenced by this principle, hypocrisy and deceit are unknown among us, sincerity and plain dealing distinguish us, and the heart and tongue join in promoting each other's welfare and rejoicing in each other's prosperity.

Wow! All that from one simple sentence in the Charge. This exercise helped me realize that our ritual offers so much great moral instruction that we can easily be overwhelmed by it. We hear the words we say in Lodge, but do we really think about their meaning? As the Charge says, "Wisdom dwells with contemplation, there we must seek it."

Brethren, if we are to derive the greatest benefits of our Masonic membership: increased self-esteem and confidence – if we really want to "learn to subdue my passions and improve myself in Masonry," then we must not only hear the content of our ritual, but spend time contemplating it's meaning. Only if we do that can we expect to receive the benefits of the wisdom our venerable institution has to offer.

New Membership Management System Coming In November

We're pleased to announce that we have successfully converted the current Grand Lodge Database to a new system by Grand View Systems, headquartered in Bossier City, Louisiana. We're excited about the new capabilities it will bring our craft. Grand View is a comprehensive web platform that provides an encrypted portal where Grand Lodge, Constituent Lodges, and individual members can communicate and interact online. Grand View is currently in use by over 32 Masonic jurisdictions and 5200 lodges.

We will roll-out the new database to the membership in November, 2019, pending Grand Lodge Trustees' approval. The system is being launched with most features enabled, and new features will be released in the coming weeks. As the system becomes fully implemented we will be communicating through email and posting correspondence through the system itself.

Some of the features of this system include:

- *The ability for members to edit their own personal information*
- *A robust lodge locator*
- *Access to information that is appropriate to the fraternity only, such as lodge minutes*
- *A lodge accounting module for Secretaries and Treasurers*
- *Educational materials can be posted on the encrypted member portal and made available to members as they log into the system.*
- *Members will be able to pay their dues online if their lodge has implemented the process.*
- *The system can be used to notify the lodge's membership, either through text, phone, email, or "snail" mail.*
- *Many of the features of the membership portal are also available with an app provided for android and iPhone users. "There's an app for that!"*

The implementation of such a system is a complicated series of events and training. As with any major changes in the processes and procedures of an organization there will be issues along the way. We ask that you be patient with the implementation. The Grand Lodge will be communicating with lodge secretaries on a regular basis.
